The Parish Council, unanimously agreed that it does not object to the application in principle, subject to the following:

- It is mandatory that all trees and hedges must be retained in their existing curtilage
- All windows overlooking neighbours should be opaque

18/01247/FUL - Land off High Street, Thornton-le-Clay - Refused by RDC

Reason – "The construction of this dwelling in Thornton le Clay, an 'Other Village' (identified in Policies SP1 and SP2) requires the application of the local needs occupancy condition, as required by Policy SP21, in order to ensure that it meets locally derived need and not externally driven demand. The applicant has evidence of a past connection to the settlement but is unable to demonstrate compliance with any aspect of the Local Needs Occupancy Condition. On this basis, the dwelling's intended occupants would be unable to comply with Policy SP1 – General Location of Development and Settlement Hierarchy; Policy SP2 – Delivery and Distribution of Housing; and Policy SP21 – Occupancy Conditions – of the adopted Ryedale Plan – Local Plan Strategy. The Local Planning Authority considers that there are no material considerations to justify a decision other than in accordance with the adopted Development Plan".

## 19/97 To report any new correspondence received by the council:

Parish Council noted content of two emails forwarded by FH:

- RDC Elections 2019
- Vale Velo Sat06Apr19

The Parish Council had received a copy of an email, which a resident had sent to Foston Primary School as follows:

"I recently consulted your school website to read the available minutes and I read with interest the sections about changing the status of Foston School from VC to VA

In the minutes of the meeting on 12Sep18, it states that governors discussed the negatives – "Devolved capital would be held by the diocese and 10% paid by school for any projects". And that "SM felt, and governors agreed that the positives outweighed this negative".

To hand over capital to the diocese, which will only be given back in part, seems a huge negative, are you sure the positives outweigh this?

Am I correct in assuming that that school building and curtilage will also be handed over to the Diocese?

If this is the case, on reading the article "Outcry at church council plan to sell village hall for £750,000" in the Yorkshire Post (Page 14 / 02Feb19), I am very concerned about the whole matter.

The decisions are been made by a governing body who are by majority not from Foston and Thornton-le-Clay and in the absence of a parish consultation many interested parties may not even be aware.

In addition, I'm not exactly sure why the alignment of the RE 'curriculum is of such pivotal importance to Terrington governors? Especially, as this may be at such a great cost to Foston School!

I would like to formally request that the village are kept fully informed and I will be doing my part by forwarding a copy of this letter to the Parish Council at their meeting this week".

The resident had received a response as follows:

"Thank you for your email. At the last Governing Body Meeting of the Foston and Terrington Federation of Primary Schools on January 30th the governors decided not to continue exploring the possibility of Foston becoming a Voluntary Aided School. If the Governing Body decides to pursue it in the future we would, of course, consult with the local community as we are required to do, before making a decision.

I would like to reassure you that Foston and Thomton le Clay representation is equal to Terrington's in the Instrument of Government, the legal document which determines how governors are appointed and on the Governing Body itself. All governors are appointed on the basis that they have a commitment to both schools and ensuring they meet the needs of their local communities".

The resident noted that this action would not continue for now, but may well be restarted in the future and none of the questions were answered.

According to the website, the current governor list is made up of categories as follows:

Foundation x 6 (2 currently vacant)

It was noted that only two are residents of the parish

The Parish Council could only keep a "watching brief", but asked that the resident keep them informed.
