The Parish Council discussed this at length and the response letter was agreed as follows:

The Council noted that the applicant states that this is "not a separate property" and that "Last year....installed a shower and kitchen in the extension, so that it became a small flat for her to use".

This is believed to be untrue. We believe that this property has never been an "office and hobbies studio over", as per planning application 04/01257/FUL.

Since it was built, relatives, friends, and people holidaying in the area have stayed in this property, which has been used as a holiday let and long term let. About 10 years ago a local couple lived in it between renting out their house and moving to live and work away. Over numerous years it was rented out as a holiday home. It is still listed on the Sykes Cottages website under property reference 2246. The photos and description from the website are shown at the end of this letter. More recently it has been used at a home for two of the applicants daughters.

We have a concern that this property has been used for people to live in without planning permission and, therefore, without the appropriate fire regulations being put in place.

In addition, if this application is granted, parking will be a problem due to its positioning between two bends.

We believe that the property should only be used for what was originally granted - an "office and hobbies studio over" and that the building should remain part of the curtilage and ownership of The Granary.
